We had 13 AK47s at the Check Post. From the heavy Weapons we had one Rocket, RPG, one Mortar, and Dasha ka and 75 mm Artillery nothing else. ~~The weapons~~ I used to With (CI) and then I went to Sati Kandow Check Post. We were responsible for Guarding and Patrolling. We never Seached Vehicles completely.

The truth of the matter is the ~~the~~ Zadran tribe has complained that our check post was bothersome to them and that we are ~~highway~~ highway Robbers.

Possibly that Americans ~~was~~ understood that and attacked our check post. One day of Capture the Americans asked for tea and we did not have our Weapons on us and detained us. They did not detain us first, they beat us and pulled our nail's.

~~and~~ and they killed one of check post members by beating. It's been a while we are in jail and it's been 3 months. For Some times we were at a Compound


